

VIDEO SURVEILLANCE

PRIVACY POLICY PURSUANT TO ARTS. 13 AND 14 OF EU REGULATION NO. 679/2016 (GDPR) AND TO THE PROVISION OF THE DATA PROTECTION AUTHORITY (APRIL 8, 2010)

DATA CONTROLLER AND CONTACTS

The Data Controller is Azienda Trasporti Milanesi S.p.A. (ATM) with registered office in Foro Buonaparte 61, 20121, Milan (Italy). The Data Protection Officer, whom you can contact to exercise your rights under art. 13 and/or for any clarifications regarding personal data protection, can be contacted at the following email address: rpd@atm.it.

PURPOSE OF THE PROCESSING AND LEGAL BASIS

The purpose of the processing is twofold:

- a. "protection of assets", whose legal basis is a legitimate interest pursuant to art. 6 par. 1 letter f) of EU Regulation 679/2016;
- b. "control of the exercise", whose legal basis is the performance of a task of public interest or related to the exercise of public authority, which is vested in the holder (safety and security), pursuant to art. 6 par. 1 letter e) of EU Regulation 679/2016.

Appropriate and clearly visible pictograms are affixed in the vicinity of each video-surveillance area and before the camera's range of action, in accordance with the Data Protection Authority.

CATEGORIES OF DATA PROCESSED AND RECIPIENTS

Pictures and video footage are handled. The data are processed by authorized personnel formally appointed by the data controller and may be communicated to law enforcement agencies and judicial authorities, and available to companies that provide goods and/or services related to the processing. An example of these would be by security companies appointed by ATM and by companies that carry out maintenance work on plants.

METHODS OF PROCESSING AND POSSIBLE TRANSFER OF DATA

The data are processed only for the purposes mentioned above and according to the principles of lawfulness, correctness, transparency, accuracy, integrity and confidentiality, established by the regulations in force. No personal data collected will be transferred outside the European Economic Area.

DATA RETENTION PERIOD

The data will be stored for a maximum of 7 days.

DATA SUBJECT RIGHTS

All the rights of the data subject are guaranteed in accordance with the provisions of Articles 15, 16, 17, 18, 20, 21, 22 and 77 of the GDPR:

- right of access to your personal data and all information on the processing carried out;
- right to rectification of inaccurate personal data and integration of incomplete data;
- right to erasure ('right to be forgotten');

- right to limit the processing of your personal data;
- right to data portability;
- right to object to the processing of your personal data;
- right not to be subject to a decision based solely on automated processing;
- right to lodge a complaint with the Italian Data Protection Authority in case a violation is thought to have been carried out.
